Called to order at 6:01 pm

Board discussed CD options. Patty will look into CD' s and get rates. This will be put on the January 2026 agenda. If all agree they will need to pass a resolution.

Shannon asked about the town getting a credit card for the town for town purchases. Trevor made a motion to approve the town getting a credit card with research, Shawn seconded, all in favor. Shannon will look into rates.
