

Town Board Meeting Minutes  
From January 12<sup>th</sup> 2026

Called to order at 6:31 pm

Board members present: Steve Cisewski, Trevor Obremski, Shawn Brandt

Also, Treasurer Patty Worzalla-Lepper, and Clerk Shannon Brandt

Trevor made a motion to approve the minutes from December 8<sup>th</sup> town board meeting, Shawn seconded. All in favor.

Cedric asked if the town has any updates or if we heard anything from TDS or Bug Tussle. The town has not heard anything.

Dan Wisz has concerns about not enough salt and sand on Camp Rd. Steve stated we will get more salt and sand on the road

Annual meeting is scheduled for Tuesday April 21<sup>st</sup> at 7:00 pm

Land use planning - Steve made a motion to increase the pay to \$35 per meeting & \$16 per hour. We need to get more people for this committee.

Trevor made a motion to add Training & Research. The pay will be \$16 per hour, Shawn 2<sup>nd</sup>, all in favor.

Move fence \$6.50/rod to bottom left corner. Pay will stay the same

Internet clerk/treasurer – will stay the same at \$30 per month

Mileage reimbursement will stay the same at 0.65 per mile

Trevor made a motion that the town board must approve all purchases over \$250. Shawn 2<sup>nd</sup>, all in favor.
