

Town Board Meeting Minutes

From October 13th 2025

Called to order at 6:33 pm

Board members present: Steve Cisewski, Trevor Obremski, Shawn Brandt

Also present were Mike Bertie from Shantytown snowmobile club, Nick Enders from MC District Supervisor, and Lane Loveland

All stood for Pledge of Allegiance

A motion was made by Shawn and seconded by Trevor to approve the minutes from the September 8th town board meeting approved by unanimous consent.

Zena is asking for the towns support to get the MC ordinance changed for fence height. There are two proposals, one by Lane, a family friend of Dohls, and another ordinance by Nick, the District Supervisor. They would like to amend the ordinance and are putting forth a proposal to align with the state of Wisconsin. 12 ft. fence for front and sides of property. Trevor made a motion to accept Nicke amendment, Steve seconded. 2-1 in favor.

Mike Bertie from Shantytown Snowmobile Club asked for permission to continue with running their trails in the ditches as years past. The club needs to make sure snow it kept off the roads while grooming the trails. Trevor made a motion to allow Shantytown Snowmobile Club access to the ditches, Shawn seconded approved by unanimous consent.

There was a discussion with Shirley & Randy Gorka who are concerned about the price increase with the snowplowing rates for 2025-2026 winter. The board and residents compromised with a new price. Flat rate of \$350.00 and .25/foot up to 10 plows. After 10 plows the town will charge 10% more per plow of their original rate. Shawn made a motion to change snowplowing rates Steve seconded approved by unanimous consent. Patty will resend proposals to residents who utilize this service.

Traffic counter report on Harvest Moon Rd. average of 42 cars per day on the North side and an average of 25 cars per day on the South side.

Brush removal on Ciszewski Rd. is almost complete. Wire is removed; there are a few fence posts left.

Steve suggested we get bids for ditching, but will wait until the town owns the land. The plan is to make the road more uniform, and as of right now the ditches are not up to standard. Tim Meis suggested Cory Westfaul for the ditching.

Tax levy increase is the same as last year. The special meeting scheduled for Monday 10/20/25 at 7:00.

Dog license for MC is going up to \$20.00

Treasures report had a balance of \$185,976.77. Treasurer and clerk reconciled books

Shawn made a motion to adjourn the meeting, Trevor seconded.
